Sub:- School Education – Request for pay fixation to the teachers who was appointed through DS-2008 and DSC-2012 – Necessary instructions – Requested – Reg.

With reference to the 3<sup>rd</sup> cited I wish to inform that, Government while enclosing the letter of the President, STU AP has requested examine and furnish the remarks. Wherein President, STU AP has stated that, the teachers who are recruited through DSC 2002 as SGTs and subsequently selected through DSC-2012 as School Assistants pay fixed as follows:

Further he has informed that, the teachers who are selected as School Assistant on 10-11-2013 are already drawing Rs.29,760/- in the cadre of SGT. But the minimum pay of School Assistant is Rs.28,940/- and there is no pay protection to them and also showing directly Rs.32,340/- in PRC 2015 for Rs.15,280/- is not justice and requested to do justice.

Further I wish to inform that, the President, APUTF has informed through the reference 1<sup>st</sup> cited, due to certain administration reasons the teachers who are recruited through DSC 2008 are appointed on 01-07-2011 and completed apprentice period on

01-07-2013 and they are eligible for regular scales after completion of apprentice period. Further, the SGTs who are appointed through DSC 2012 are allowed regular scales from the date of joining and pay was fixed at Rs.23,100/- on 01-07-2013 in new P.R.C.

Further informed that, the pay of SGTs who are recruited through DSC 2008 are fixed at Rs.21,230/- (minimum scale) and after allowing notional increments fixed at Rs.22,460/- and losing one increment even though they are seniors to the teachers who are recruited through DSC 2012. Further, the School Assistants who are recruited through DSC 2008 pay was fixed at Rs.28,940/- (minimum scale) + notional increment Rs.30,580/- but the School Assistants who are joined on 28-12-2012 through DSC 2012 pay was fixed at Rs.31,460/- which is higher than the School Assistant pay who are recruited through DSC-2008. Further I wish to inform that, the President, APUTF has requested to cancellation of apprentice since Government have issued orders vide G.O.Ms.No.52, Dt.25-02-2010 for cancellation of apprentice as per recommendations of 9<sup>th</sup> P.R.C. and also requested as follows:

1. Notional fixation in the regular scale in respect of DSC 2008 teachers.
2. Fixation of pay on the day of completion of 1<sup>st</sup> year apprentice i.e. on 01-07-2013.
3. Allowing pre-mature increment as per F.R.27.
4. Allowing option to increment date in 10<sup>th</sup> P.R.C.

Further I wish to inform that, Sri G.Srinivasulu Nadiu, Hon'ble MLC has requested through the reference 2<sup>nd</sup> cited that, to stepping up facility to regularize the salaries in respect of teachers who are recruited through DSC 2008 and DSC 2012.

In this connection I wish to inform that, the Chief Account Officer of this Office has given the following remarks on the above issues:

"Cancellation of apprentice in case of candidates selected and appointed in DSC-2008 does not arise, as Government order is effective retrospectively i.e., from 25-02-2010. The following remarks are submitted:

Thus the request of the Association is irrelevant in this case. |

With regard to teachers appointed in DSC 2008 as SGT and selected to SA in DSC 2012, extending the benefit under FR 22(a)(iv) to protect the pay drawn in the lower post. As per FR 22(a) (iv), the pay of a regular Government servant when appointed to another post under the Government on selection. In this case the appointment is made under Local Body/Municipal managements".

In view of the above I request the Government, kindly peruse the above factual position and issue necessary instructions in the matter.
