The attention of all the Deputy Educational Officers/Mandal Educational Officers in the District are informed that as per the instructions issued in the reference 2<sup>nd</sup> cited an exercise was done in the District with regard to Resource Redistribution – Rationalization duly constituting a Mandal Level Committee. Accordingly, the schools for (a) Establishment of Adharsha Pradhmika Paatasala (Model Primary School) and the schools for (b) Positive Consolidation of Schools have identified in the District.

Accordingly, all the Mandal Educational Officers in the District are hereby informed that the Government in the reference 1<sup>st</sup> & 2<sup>nd</sup> cited have approved for Establishment of “182” Adharsha Pradhamika Patasala (Model Primary Schools) and “10” Positive Consolidation Schools in Krishna District. The list of establishment of Adharsha Pradhamika Patasala (Model Primary Schools) and Positive Consolidation Schools are herewith enclosed in ‘02’ Annexures along with these proceedings and communicated to all the Mandal Educational Officers in the District for ready reference and to take immediate necessary action as per the instructions of the higher authorities from time to time.

In this connection, all the Mandal Educational Officers in the District are informed that in the reference 5<sup>th</sup> cited, the Commissioner of School Education, AP, Hyderabad has issued certain instructions with regard to Consolidated schools during 2015 as follows.

**Instructions on Consolidated Schools**

In the above circumstances, the following instructions are issued for strict compliance:

- a) Transit / Admit all the students studying in the school which was identified for consolidation in the newly established Adharsha Pradhmika Paatasala (Model Primary School) and in the Positively consolidated schools, as the case may be.
- b) Ensure handing over of all the records pertaining to the students i.e. Admission Register / Record Sheet / T.C. Register / Staff Register / Posts sanction register and all other documents / all bank accounts pertaining to special fee, SMC Funds, M.D.M. Funds along with balances of Rice etc., registers to the newly established Adharsha Pradhmika Paatasala (Model Primary School) and in the Positively consolidated schools.
- c) Shift the furniture and other equipments / materials to the Adharsha Pradhmika Paatasala (Model Primary School) and in the Positively consolidated schools.
- d) Shall maintain a record of all the above in the Adharsha Pradhmika Paatasala (Model Primary School) and Positively consolidated schools / Office of Mandal Educational Officer.

Further, the concerned Mandal Educational Officers in the District are hereby informed that the following teachers (SGTs) who are merged to the newly established Adharsha Pradhamika Patasala (Model Primary Schools) and Positive Consolidation Schools in the District and instructed that the individuals shall be relieved on the A.N. of 31.10.2015 with instructions to report to the newly established schools on the F.N. of 01.11.2015 along with the students studying in their schools as shown hereunder:
